

# New turf establishment exemption

APPLICATION FOR CUSTOMERS ON STAGE 2 ONLY (UP TO 28 DAYS)

Under Stage 2 Water Restrictions which came into effect on 15 December 2008, you are no longer permitted to water a private lawn area using reticulated water from the Coliban System. In order to consider granting an exemption for the establishment of new turf, we must be satisfied that the owner has a plan in place to sustain the lawn area at the end of the exemption period. The plan must show how other sources of water will be utilised to achieve this into the future.
