This form is to be completed by a person who would like to cancel an existing water licence or surrender a portion of their water allocation and retain a portion of their water allocation on an existing water licence.

Once the water licence is surrendered it cannot be re-obtained. To obtain a water licence, an applicant must purchase a water right from another licence holder. An alternative option to surrendering a water licence is to sell the water licence through a permanent water transfer.
