

# Temporary Licence Transfer



Version 12.0 - June 2024

This form is to be completed by a licence holder who wishes to temporarily transfer licence volume (whole or part) to another licence holder for the current rural season. *Current Licence holder, complete sections A and C. Purchaser of Licence, complete sections B and C.*

A transfer is for the current rural season only and the temporary transfer will be automatically reversed at the end of the financial year.

Only property owners already holding a water licence can seek additional water for their property through temporary transfer of a water licence volume.

The Victorian Water Register only allows for water to be traded once. It cannot be on-traded a second time to a third party.

If 100% of the permanent volume is temporarily transferred and the seasonal allocation is increased after the transfer takes place, then the buyer will have the benefit of the increased allocation.
